- Own, reproduce or keep any publishable materials
- Accept publishable materials previously printed by any other publishing company, or self-published material.
- Provide advertisement for clients, or promotions (referral services must be selected for promotions)
- Edit or print any materials for book publishing (referral to PTWO editors and printers only.)
- Fund, or promise funding to authors for book publishing services or fund businesses for grant purposes.
- Be liable for damaged, lost, or stolen publishable materials, books or any materials given to PTWO for publishing. (Authors are responsible for their manuscripts)
- Be legally responsible for Editors, Printers, Graphics companies and other nonprofit corporations or companies, etc. (separate contracts with these entities is necessary)
- Handle, transport, mail or distribute author's original, or copies of manuscripts to editors or printing, (Authors are responsible for transporting their documents to editor and printer referrals.)
- Refund any sponsor's proceeds or donations, return any publishable files.
- Refund referral fees and related fees.
- Reprint books, manuscripts, etc. published by another publisher/company.
- Pay for any expenses incurred by authors, business, and organizations in return for our services.
- Be employed by any of the organizations contracted with PTWO for grants, or any business related duties.
- Pay for the printing of any publishable or typed manuscripts, business plans, etc.
- Campaign or provide advertising or marketing for ANY company besides PTWO.
- PTWO will not be responsible for travel expenses, or any expense of contracted organizations, authors, participants, or clients.

# PTWO-Push The Word Out Publications Contract Price, Terms and Conditions: 1-Year Limited Contract

**Initial Consultation**: \$250.00 (non-refundable- includes online consultations as well.) **Each additional consultation**: \$200.00 plus \$50.00 an hour not to exceed 3 hours in one day. (non-refundable)

Grant proposals and applications require initial consultation fee and hourly fee after consultation. Grant contracts are a 1 year limited agreement signed by both parties. PTWO will receive compensation of 15% of the awarded grant funding from each foundation grant submission.PTWO has the right to cancel this 1-year limited contract for non-compliance to the contract agreement.

Business Clients will pay initial consultation fee and \$50.00 per hour not to exceed 3 hours in one day (non-refundable) writing business plans, portfolios, grant research and writing fees.

Author/Client must pay initial consultation fee and 50.00\_ISBN fee (non-refundable) and 50.00 Copyright fee. (non-refundable) Authors must pay 50.00 an hour for additional editing, or printing work, changes in documents, etc.

PTWO will refer client to contracted Editor and client must sign additional contract with editor along with any fees negotiated to editor. (For Authors Only)

Other business referrals are 50.00 each referral.

Resume writing and printing is \$25.00 an hour minimum, maximum not to exceed 3 hours in one day)

Editor (after payment received) will consult with printer and refer client to printer. Client must sign agreement with printer along with any fees negotiated to printer. (For Authors Only) All fees to PTWO, Graphics Company, editor and printing company must be paid or books will not be printed. If client refuses services from editor and printer, PTWO will not be liable for legal ramifications with referral disputes. (For Authors Only)

# PTWO-Push The Word Out Publications Privacy Policy

Updated June 1, 2019

Our privacy policy, as written below, answers questions authors may have about access, security, and control of personal information. It describes how the information will be used and whether it will be provided to third parties.

All companies that are contracted with PTWO Publications including your name, address, telephone number, email address and credit card data---belongs to author. While PTWO may collect this type of information when you provide it to us, we do not rent or sell your information to third parties.

We use it only to process your publishing, consulting, editing and printing orders and to provide a more personalized experience.

WHAT INFORMATION DOES PTWO and contracted companies collect?

When users visit our website (s), there are two types of information that may be collected.

The first type of information is known as personally identifiable information. In order for us to serve your needs and provide products and services, we may from time to time request personal and private information, such as your name or company, address, contact information, education, payment information whenever orders are placed. You may choose to provide this information at your discretion.

Many areas of our website are accessible without providing any personally identifiable information. Personally identifiable information excludes any information you may choose to submit publicly, such as reviews, critiques, editorials, testimonials, documentaries, forums, blog discussions, or entries into PTWO's magazines, journals etc.

Because PTWO wants to serve you better, we may share your name, book information and contact with companies that are contracted with PTWO Publications. Other contracted companies with PTWO may offer products or services useful to you. PTWO Publications share some aspects of common ownership and control.

Contracted companies currently include PTWO Publications, Contracted Editing companies, Contracted Printing Companies, and Contracted Marketing and Advertising companies.

You e-mail address may be used occasionally to notify you about important changes to PTWO's Web site, new services, and special considerations which we find valuable to you. This opt-out does not apply to information collected via email to facilitate, complete or confirm our contract, transactions with you, to provide warranty or security information, or to notify you of changes in our terms, features, or to deliver goods or services, including updates, or upgrades, that you are entitled to receive.

We may release account information when it is believed, in good faith, that such release is reasonably necessary to (1) comply with law, (2) enforce or apply terms of any of our user/client/contracted agreements, or (3) protect the rights, property, or safety of PTWO Publications and its affiliated and contracted companies, users, or others.

We may release account information when we believe, in good faith, that such release is reasonably necessary to:

Respond to subpoenas, court orders or legal process; to establish or exercise our legal rights; or defend against legal claims.

Believe it is necessary to share information in order to investigate, prevent or take action regarding illegal, fraudulent and potential threats to the physical, and mental safety of any person, violations of PTWO Publications terms of use, or as otherwise required by law.

Transfer information about you if PTWO is acquired by or merged with another company. Upon this event, PTWO will notify you before information about you is transferred and becomes part of a different privacy policy.

The 2<sup>nd</sup> type of information is known as "non-personally identifiable information" and is collected upon each visit to our Web site. Our server automatically recognizes visitors' domain names and Internet Protocol addresses (when possible). We also collect information, which is collected and maintained in an anonymous, non-personal and composite form, allowing us to improve the content of our Web site and facilitate market research when necessary.

PTWO and its contracted Web Server uses encryption technology to keep your personal information safe. All ordering information—including your name, mailing address, telephone number, e-mail address, and credit card data is encrypted using a secure server for security.

Credit card transactions are handled by a third-party institution (PayPal) and they receive the credit card data only to verify the information and process transactions.

Furthermore, your credit card and billing information cannot be read as it travels to our ordering system. In order to ensure that your information is more secure, once your credit card information is received, the server may store only the last 5 digits which is NOT accessible from the internet or Web site.
